1) Welcome, Introductions, Apologies and Housekeeping – Brian Walker, Chair

2) Independent Member Feedback – Living well for longer & gym attendance

- > SE is frustrated that told all sorts of services and options are available to her but as doesn't require the level of service she would be offered (ie doesn't need someone to assist getting dressed etc) finds after applying she isn't eligible. Adding that due to very poor mobility has bought lots of equipment to support her independent living but at her age it is a very difficult situation and this frustration does not help.
- > Positive news SE has returned to the gym after a Health and Safety incident occurred prior to Christmas. Feel the staff listened to her feedback and do care. By attending the gym feels mental and physical health improves/stabilises.







3) Healthy Places Joint Strategic Needs Assessment- Bryn Hilton, Public Health What is a Joint Strategic Needs Assessment (JSNA)?

- > Reviews the wider determinants of health the Community, the environment and economy where you live and how this affects you.
- > Analyzing data, reviewing evidence, looking at current service provision, having stakeholder engagement, identifying gaps and sharing recommendations.
- Joint = Multi-agency working (local/ combined authority, ICB, academics, public etc)
- Strategic = Aiming to influence whole local system (not just a single organisation)
- > Needs Assessment = Reviewing the health status of a certain group/ groups with respect to a specific topic ie older people, disabilities, carers needs.

Healthy Places JSNA Aims to ...

> Create system-wide recommendations to support the development of healthier, easy to access and inclusive communities across Cambs and Peterborough.

JSNA Timeline

- Now April Community Survey open.
- > April, May, June attending Healthwatch Partnership Boards, Health & Care Forums.
- June/July pulling together, creating, bringing JSNA to Health and Wellbeing Board.
- > Autumn 2024 Agreed recommendations to form actions in Cambs & Peterborough.

Comments, Questions and Answers

- > BW Aging highlights the increased need for social interaction as less able to go out. le older people are entitled to a bus pass but that presupposes you can access a bus service near you. Cutting down chances of getting/attending health appointments.
- > Alison Bourne noted Care Together have also found many older people talk about transport being a major barrier to social isolation.
- Mentioned many villages have volunteer car schemes, which will take people to GP appointments but recognized they don't cover every area.
- **Q** MM how important does Bryn see transport and meeting people on peoples welfare?
- A It's a balance. Agreed transport for people meeting up, having in person meetings has a lot of benefits for social interactions, productivity etc however it can exclude people who cant make it and theres environment considerations too.

4) Older Peoples Services – Belinda Child, PCC and Alison Bourne, CCC Belinda Child, Adult Social Care Operations - Peterborough City Council

- > Work continues on Self-Assessment Document and preparations for unannounced CQC inspection - looking at waiting times and ensuring learn from other inspections.
- All Age Carers Strategy now out.

Comments, Questions and Answers

- **Q** What are the current waiting times for initial referral interventions?
- A For Adult Learning Help contact through front door approx. 2500 a month, of this 70 people are waiting 5 weeks for initial assessment.

Alison Bourne, Accommodation Commissioning – Cambs County Council

- Message from Graeme Hodgeson Care Together announcement coming soon about new pot of seed funding of £250,000 for small voluntary organisations that support older adults to bid for, across Cambridgeshire (including rural areas).
- Care Micro-Enterprise directory is now live. CMEs are people providing older adults personal, local care. The directory aims to make it easier for people to find services.

5) Care at Home in Peterborough, Commissioning Update – Ruth Miller, PCC Review of current contract and areas for development

- > The existing contract is ending March 2025, so go to market summer 2024 to be able to award and start new contract with new providers by March 2025.
- > Closed Framework contract we go to market with once, and the providers that are on there are there for the duration of the contract, in PCC this is up to 10yrs, till 2028.
- ✓ Benefits means can work with specific providers closely, maintain quality and relationships, as well as the same terms and costs.
- × Negatives can be difficult as it means if there are providers who leave the market or who we no longer want to work with, then we can only work with those that are left.
- × PCC lost 27% of providers so, now use PCC framework first, and then CCC dps.
- Market change over time, now get multiple care agencies bidding for same package.

Current Commissioning Issues...

- Specialist care difficult to source (children's, mental health, learning disabilities).
- Hard to fill packages in rural areas or contracts including homecare/supported living.







Want to hear from people who use PCC services:

- **Q** What do you think works well in homecare? Choice and control over provider, short waiting times to start care, kind and caring staff.
- **Q** What could our providers do better? Late calls, lack of communication from the agency's office, not being able to choose specific call times.
- **Q** How can we make sure we keep doing the good things, and what can we do to ensure providers improve? The tender - questions ask providers when they bid, the evidence they provide to demonstrate the quality of care delivery/ quality threshold. Terms and conditions – include requirements in the specifications and contract for providers to adhere to and hold them accountable to. In the quality monitoring – KPI's, data returns, regular meetings, monitoring visits.

Comments, Questions and Answers

- > Homecare users are very reluctant to comment whether service is good, bad or indifferent. People would rather receive a bad service than risk loosing it.
- Lynne Hayden Age UK Cambs and Peterborough said the most common issue they are aware of is frustration over times – not being able to choose call times, getting up/going to bed being out of the cared for control.
- **Q** Are surveys anonymous so cared for don't have to worry about repercussions or getting carers into trouble if late attending etc?
- A Online and paper forms are anonymous unless choose to include contact details. But difficult when social workers do reviews who always ask about care provider.
