4) Presentation: Care Together – Jessica Weeds, County Council

- > Programme to help older people continue to live independently and happily in their own home
- > It is part of the Early Intervention and Prevention services
- Place based approach to commissioning of services
- > Aim to increase active library membership by 10% by 2026
- Aim to increase uptake of Healthy You by 7% by 2026
- Create 151 micro community enterprises by 2026
 - o These are local people providing supported to set up their own small business to provide care and support to people in their local area
 - Longer lasting relationships between care worker and client
 - o Make a difference to people's lives where employment opportunities are often limited

5) Physical Disability Team Update

Philippa Avey-Walters - Peterborough City Council

- Lots of work in understanding and preparing for the commencing of CQC inspections within adult services - particularly around how we can evidence the work that we do and the impact we make to people's lives.
- > We're holding a staffing session this week to look at theme 1, which includes completing assessing, how we manage our waiting lists etc.
- > We have recently launched a pilot feedback process for those with lived experience accessing our services, including accessibility in terms of the best way to obtain feedback from a range of individuals. I know Healthwatch have been involved in this.
- > Lastly one of the things the board are interest in is understanding waiting list timescales - we have a RAG (Red, Amber, Green) rating system for low to high priority. We also measure the number waiting, the longest waiting and the median (middle number).







- > At the end of January:
 - o The figures for the Adult Early Help Team (front door, first assessment is 07/12. 68 on waiting list (Completed 76 assessments in the month)
 - o The Community Long Term Team where the on-going work or level of complexity goes is 31, oldest 01/09/23, median 20/12/23
 - o The Review team have 653 Overdue stat reviews we have a review plan in place to improve this currently 60% - aiming for 70% by year end. (completed 103 in month) (found we have contact but not completing the stat review) review at right time for the person - not necessarily when due. But earlier if we have contact.

Karen West – Cambridgeshire County Council

- > Preparing for the CQC inspection, ensuring sufficient evidence is available to tell the story of people who access services and the staff who support and make decisions.
- > All areas have waiting lists, people on the waiting list are being contacted on a regular basis to ensure that the situation hasn't changed.
- > Recent increase in referrals relating to self-neglect

Diana Mackay, Cambridgeshire County Council

- Commissioning is split into two teams:
 - o Community Team
 - Domiciliary Care
 - Day Opportunities
 - o Accommodation
 - Care homes
 - Housing related support
- > Diana explained that she is responsible for commissioning of the Community Equipment Service and the Community Occupational Therapy service.
- > The Community Occupational Therapy Service is an all-age service and has an average waiting list of 6 weeks - referrals are triaged so that the more urgent cases are dealt with first.
